

### **Terms and Conditions:**

The discounts associated with the **Troy Heritage Private Dental Plan** are available only through Dennis T. Myers, DDS.

Monthly membership fees are to be paid for a minimum twelve (12) month period and are non-refundable. Unless waived by the dentist, membership will automatically renew on the anniversary date and continue thereafter until cancelled, in writing.

Qualified dependents are defined as applicant, applicant's legal spouse and any non-married children under age 21, living in the household. Any additional dependents after three (3) each will have an additional surcharge of \$12 per month per dependent.

Fees and plan discounts are subject to change without notice.

Missed or broken appointments without 24-hour notice will be charged \$20.

All member co-payments are due at time of service. Membership in the Dental Plan may be terminated for abuse and failure to pay membership fees or properly billed work.

**Troy Heritage Private Dental Plan** is administered solely by the dental office and may be discontinued at the end of any month, with or without notice.

Patient may be subject to a credit evaluation. Members who do not qualify for approved credit will have an increased premium amount.

### **Plan Limitations and Exclusions:**

**Troy Heritage Private Dental Plan** benefits are limited to \$1250 per each covered family member per year.

Prophylaxis is limited to twice every calendar year per member. A difficult prophylaxis (i.e. heavy smoker, neglected teeth, etc.) is subject to a \$20 surcharge.

Fluoride treatments are limited to twice every calendar year per member, up to age 14.

All covered replacements are subject to the co-payment percentages as listed in the Schedule of Services.

### **Plan Limitations and Exclusions (continued):**

Any dental procedure in progress or performed before or after a member's eligibility period is excluded.

Bleaching of teeth for cosmetic purposes is excluded.

Replacement for lost or stolen bridgework or appliances is excluded.

Coverage for dentures (removable prosthodontics) is excluded.

Any dental procedure not listed as a covered service, including but not limited to, anesthesia, prescription medications, emergency dental service, etc. is excluded.

Treatment required due to hospital and medical charges or self-inflicted wounds of any kind is excluded.

Treatment to correct congenital, developmental, or medically induced dental disorders is excluded (i.e. TMJ).

Lab fees are excluded as a covered service and are payable in addition to the member's co-payment.

Any dental services provided to the member by state, county, or municipal agencies or dental services provided without cost to the member are excluded.

Dental Plan discounts for dental services provided in association of benefits received from an alternate source (i.e. workman's compensation) is excluded.

Coordination of **Troy Heritage Private Dental Plan** benefits with other plans is excluded.

Periodontal maintenance services are excluded under the base Premium Plus plan. A non-surgical periodontal maintenance rider can be purchased, in addition to the base plan, for \$30 per member per month.
